Agreement

BACKGROUND: The Company (Conscious Magazine) and the _____ (Fashion Brand) are entering into an agreement (the "agreement") with respect to accessing confidential information in order to properly manage and progress (CM) business.

In connection with the Agreement (the "Permitted Purpose"), the Fashion Brand has requested certain confidential information (the "Confidential Information") regarding: current and future ideas, magazine stories, contact information, etc.

IN CONSIDERATION OF and as a condition of the Company providing the Confidential Information to the Fashion Brand in addition to other valuable consideration, the receipt and sufficiency of which consideration is hereby acknowledged, the parties to this Agreement agree as follows:

A. Terms of Service and Conditions.

The contract between company and Fashion Brand shall bind for the stated issue. The Fashion Brand commits to 1) Shipping / Dropping off fashion items on or by November 01, 2015 2) Responsible for the pick-up of fashion items (if dropped off) 3) Responsible for the shipping label returns if shipped.

B. Restrictions.

It is understood and agreed between the parties that the Agreement is not intended to nor does it create an employment contract between company and Fashion Brand, nor does it create a joint relationship or partnership between the parties hereto. Fashion Brand is not entitled to benefits that company provides to company employees. Print copies will be made available at a discount to collaborators.

C. Confidentiality.

Prior to the release of the magazine, Fashion Brand should not share contents of the magazine development with external entities without permission from the Conscious Editorial Team.

D. Termination.

Please be advised that if the Company believes the Fashion Brand does not represent company values, or if there is a breach of contract, then the Company has the right to terminate the contract.

E. Waiver.

For Consideration herein acknowledged as received, and by signing this release I hereby give the Conscious Magazine and Assigns my permission to license the Content / Photo and to use the Content / Photo in any Media for any purpose (except pornographic or defamatory) which may include, among others, advertising, promotion, marketing and packaging for any product or service. I agree that the Content / Photo may be combined with other images, text, graphics, film, audio, audio-visual works; and may be cropped, altered or modified.
