### Agreement

BACKGROUND: The Company (Conscious Magazine) and I, \_\_\_\_\_ (Collaborator = Producer, Writer, Photographer, Designer, Illustrator, Feature) are entering into an agreement (the "agreement") with respect to accessing confidential information. In connection with the Agreement (the "Permitted Purpose"), the Collaborator has access to confidential information regarding: current and future ideas, magazine stories, contact information, etc.

### A. Terms of Service and Conditions.

The agreement between company and collaborator shall bind for the stated issue and is a volunteer position in exchange for exposure (byline in print magazine, on consciousmagazine.co and via social media mentions). The Collaborator commits to:

- Providing content (whether a written submission, photography, design, or illustration) as previously specified by the Editorial team
- Providing contact details for any story features
- Lending and approving content submission for public use to the Company (as approved by Conscious Magazine's Editorial team).
- Recognizing that due to design and content management during final production stages that the content submission may be altered in the following ways: the story may be shortened from its original form, the direction of the piece may be changed, removed, etc.
- Upon release of the magazine, helping to promote involvement in collaborating on Issue 07 by sharing via social media, newsletters, emails, etc.

**B. Expertise.** Collaborator represents that he / she has the background, training and experience to perform properly the services to be delivered under this agreement.

**C. Restrictions.** It is understood and agreed between the parties that the Agreement is not intended to nor does it create an employment contract between Company and Collaborator, nor does it create a joint relationship or partnership between the parties hereto. Collaborator is not entitled to benefits that Company provides to Company employees.

**D. Confidentiality:** Prior to release, collaborator should not share contents of the magazine development with external or online entities without permission of the Conscious editorial team.

**E. Termination:** Please be advised that if the Company believes the Collaborator does not represent company values, or if there is a breach of contract, then the Company has the right to terminate the contract.

**F. Complimentary Copies and Credit:** Collaborators will receive name credit within the credit pages and attached to the Collaborator's content. Collaborator will receive 1 (to 5) complimentary copies of Issue 07 pending on the collaborators level of contribution. To be determined with Conscious Editor.

**For Consideration** herein acknowledged as received, and by signing this release I hereby give Conscious Magazine my permission to use the content or photography submitted in any Media for any purpose (except pornographic or defamatory) which may include, among others, promotion, marketing and packaging for any product or service related to Conscious Magazine in Print.

I agree that content or photography may be combined with other images, text, graphics, film, audio, audio-visual works; and may be cropped, altered or modified. *Photographers* will have secondary rights to the photography and all rights to the content belong to Conscious Magazine.
